To Whom It May Concern

The Danish Business Authority is the competent authority in Denmark for control of exports of items listed in Annex I of EU Council Regulation No 428/2009 as amended by EU Commission Regulation No 2017/2268.

On the 12th of June 2019, the Danish Business Authority received Lars Thrane A/S' application for a technical assessment of a **satellite communications system**.

In this connection, the Danish Business Authority can inform you that the Danish Defence Acquisition and Logistics Organisation (DALO) has performed a technical assessment of the product "LT-3100 Satellite Communications system" from the company Lars Thrane A/S, Skovlytoften 33, DK-2840 Holte, Denmark.

According to DALO, the product consists of a LT-3100 maritime satellite phone, which can send and receive audio and data with the use of the Iridium satellite network.

DALO's overall assessment is that the product is not listed in Annex I to Council Regulation No. 428 of the 5 May 2009, as amended, cf. EU Council Regulation No. 2017/2268.

Moreover, the product is not considered to serve any purpose related to weapons of mass destruction or their means of delivery, nor is it considered, wholly or partly, to serve any military purpose in a country subject to an arms embargo, cf. the catch-all provisions of Article 4, 1-2 of the Council Regulation.

This means that the above-mentioned product is not subject to export control in respect of dual-use items.

Furthermore, the product is not considered to be covered by section 6 of the Danish Offensive Weapons Act.

This statement does not exempt Lars Thrane A/S or other companies or persons acting on behalf of Lars Thrane A/S from the obligation to observe and comply fully with applicable export control laws and regulations in force.
